**Camping Info:** The reservation period covers Wednesday, July 11th at **NOON** through Monday, July 23th at noon. Camping cannot be prorated. There is a limited number of camping spaces available. A wait-list will be started when all available campsites are reserved. \*Please see Refund Policy below.

**Conditions:**

1. The information I supply regarding my type of RV will be correct so that I may be accurately placed in a spot that fits my needs and space requirements.
2. I understand that no guarantee can be made that awnings will be able to be extended or that there will be room to park additional equipment or vehicles. Additional trailers may need to be unhooked and parked in a designated area.
3. Reservations will be given priority by date full payment is received. Sponsors with full payment are placed first.
4. Prepayment does not guarantee any particular spot on the grounds or placement near any specific neighbor, only that a space will be made available.
5. I agree that if I arrive after hours, I may need to be relocated to my assigned location. I agree to do this without question or argument.
6. **NO Dirt Bikes or Go Carts** are allowed on World Equestrian Center (WEC) property. No riding of golf carts off WEC property or on rout 730. Any violation of WEC rules may result in removal from the premises.
7. Raw sewage or any liquid containing septic material may only be disposed of at WEC dumping stations, or pumped by approved show service provider. Dumping on the ground of any raw sewage or wastewater (dishwater or wash water) is not allowed and may result in removal from the premises. Trailer tank pumping may be scheduled on a daily basis at show office. Payment is between pumping service and trailer owner.
8. I hereby agree that BWA, OAQHA & WEC, its employees, Board Members and/or the individual premises, is not liable for any loss or damage of any of my personal property, including but not limited to, RV's, Horse Trailer, automobiles, camping equipment and/or any items brought to the grounds.

By signing this form, I agree to hold BWA or OAQHA and its employees and Board Members, and well as the individual premise owner, harmless of any liability and indemnify the same in the event of damage or loss. By signing below, I understand and agree to all conditions and terms outlined by BWA & OAQHA. I agree to abide by all rules of WEC upon arrival. ## GOLF CART REGISTRATION FORM

Golf carts may be driven on WEC property and during the Little Buckeye or Buckeye Classic Horse Shows, with certain restrictions, which are listed below. Before your golf cart may be driven on WEC property owners must agree to terms for use.

**Golf Cart Registration Info:** Cost \$25. The reservation period covers Wednesday, July 11th at **NOON** through Monday, July 23th at noon. Registration cannot be prorated. \*Please see Refund Policy below.

### Conditions

1. Only a **licensed driver** (16 years of age or older) may operate the golf cart.
2. The golf cart must be covered by liability insurance in the minimum amount required by the State of Ohio.
3. The golf cart driver must give right-of-way to pedestrians and motor vehicles, nor drive in any manner to cause others to fear for their safety. Drivers must obey rules of the road, stop signs.
4. Driver and all passengers in a golf cart in-motion must remain seated. Reasonable seating capacity limits must be observed. Passenger or cargo overloading is prohibited.
5. A golf cart to be driven on WEC property, must first be registered in the show office (fee required) and display a current "windshield" type, adhesive WEC decal on the left front windshield (or hood if no windshield) of the vehicle, where it is easily identifiable by security/safety personnel.
6. Golf cart **may not** be driven on any State or Clinton County roadways.
7. Only those golf carts having working headlights, and taillights, will be permitted to operate on WEC property after sunset with caution.
8. Violation of these restrictions is subject to removal of golf cart from WEC property.

Golf cart owners/drivers acknowledge the inherent danger of driving on roadways shared by motor vehicle traffic. Use of a golf cart is at the owner's/driver's/passenger's own risk. BWAH, OAQHA and WEC assumes no legal or financial responsibility for damages or injuries resulting from any incident or accident involving the use of a golf cart on WEC roadways or property.

By signing I understand and agree to all conditions and terms outlined by BWAH & OAQHA. I agree to abide by all rules of WEC upon arrival. I understand that my failure to do so may result in my removal from the premises.
